

## **Te Aroha College Attendance Policy**

#### Rationale

Te Aroha College is committed to fostering an environment where regular attendance is a cornerstone of student success. Consistent attendance enhances academic performance, personal development, and future opportunities. This policy outlines the expectations and procedures regarding student attendance, aligning with the Ministry of Education's requirements and incorporating the Stepped Tiered Attendance Response (STAR) system.

### 1. Legal Requirements

In accordance with the Education and Training Act 2020, all students aged 6 to 16 years are required to attend school regularly. Parents and guardians hold the responsibility to ensure their child's consistent attendance.

# 2. Attendance Recording

• **Electronic Attendance Register (eAR):** Te Aroha College utilizes a Ministry-approved Electronic Attendance Register to accurately record student attendance for each half-day the school is open for instruction.

### 3. Absence Notification

- Parent/Guardian Responsibility: Parents or guardians are expected to inform the school promptly of any student absences, providing a valid reason.
- School Communication: In instances of unexplained absences, the school will contact parents or guardians as soon as practicable on the day of absence to ascertain the reason.

### 4. Stepped Tiered Attendance Response (STAR) System

Te Aroha College has implemented the STAR system to address and improve student attendance through a structured approach:

- **5 Days Absent:** The school will reach out to parents or guardians to discuss the reasons for absence and set clear expectations for regular attendance.
- 10 Days Absent: School leadership will convene a meeting with the student and their parents or guardians to identify barriers to attendance and collaboratively develop a plan to address them.

• **15 Days Absent:** The matter will be escalated to the Ministry of Education. At this stage, legal actions, including the prosecution of parents or guardians, may be considered as part of the intervention strategy.
